5. Cancellations require written notice within thirty-six(36)hours of delivery.
6. Rental Customers are responsible for consumables such as gas and electricity, etc.
7. Rental Customer must be licensed driver and 18 years of age or older.
8. Rental Customer is responsible for contract amount regardless of weather conditions.

1. The Lesser agrees to provide for delivery and pick up of the golf carts. _____
2. The Lesser agrees to provide all fuel. (If applicable). _____
3. The Lesser guarantess the performance of every cart.
4. EXPENSES RESULTING FROM ABUSE AND DAMAGE TO THE CARTS WILL BE THE RESPONSIBILITY OF THE LESSEE.
5. Lessee agrees that any cost to repair or replace the carts and their accessories including chargers, regardless of cause, except reasonable wear and tear, while the equipment is out of the possession of H&H Golf Cart, Inc. Any damage to carts as a result of vandalism, loss, fire, or theft will be the responsibility of the Lessee. Cost of repairs will be borne by Lessee, whether performed by H&H Golf Cart, Inc. or others.
6. The Lessee is responsible to insure that the carts will be operated under the following conditions:
 - a. Carts are to be used with the maximum of two passengers for 2 passenger carts. Four passengers for 4 passenger carts. Six passengers for 6 passenger carts.
 - b. No one under the age of 18 years of age is to drive carts. All drivers must have drivers license.
 - c. If the rental golf cart becomes unsafe or in disrepair as a result of normal use, customer agrees to discontinue use and notify H&H Golf Cart, Inc. who will replace or repair the rental golf cart if available.
7. Prohibited Uses. Use of rental golf cart in the following circumstances is prohibited and constitutes a breach of contract:
 - a. Illegal purposes
 - b. Using when in disrepair
 - c. Improper, unintended use or misuse
 - d. Use at any location other than the address furnished to H&H Golf Cart, Inc. without H&H Golf Cart, Inc.'s express permission in advance.
8. **Cancellations:** If the Lessee gives the Manager at H&H Golf Cart, Inc. thirty-six(36) hours notice of a cancellation there will be no charge for cancellation and full refund will be given.
9. If the Lessee cancels while carts are in route to location, the Lessee will be responsible for transportation cost of the carts. (1/2 of the daily fee per each cart shipped).
10. **Consent and Release:** Lessee understands his rights and responsibilities and voluntarily consents to have H&H Golf Cart, inc. 's provide the stated equipment, and furthermore releases H&H Golf Cart, Inc., and its directors, officers, representatives, employees, agents, successors, and assigns from all legal responsibility and liability for any injuries or property damage caused by the improper use, unauthorized, and or negligent use of golf carts.

11. **Time of Return and Late Return:** Lessee agrees to return golf cart(s) on the expiration of the rental period and retention of possession, after this time without a new agreement constitutes material breach of this contract. Any extension must be mutually agreed upon in writing. ***There is \$3.00 fee (per key) for any unreturned keys.*** If applicable, Lessee agrees to return golf cart(s) during normal business hours and in a timely manner. If not returned in timely manner, Lessee shall pay the additional rental fees.
12. This contract is not a contract for sale. H&H Golf Cart, Inc. retains full rights to the golf cart(s) rented. By execution of this agreement, the Lessee acknowledges that if the golf cart(s) are not returned as provided as herein, H&H Golf Cart, Inc. may institute legal proceedings against the signers to recover the golf cart(s) and for any and all damages which H&H Golf Cart, Inc., may suffer as a result of the Lessee's failure to return golf cart(s) in good condition.
